Regions or areas in the country that are politically disputed by any other countr(y)(ies) or which are claimed by other countr(y)(ies):

The Republic of Azerbaijan declares that it is unable to guarantee the implementation of the provisions of the Green Card System in its territories occupied by the Republic of Armenia (the Nagorno-Karabakh region of the Republic of Azerbaijan and its seven districts surrounding that region), until the liberation of those territories from the occupation and complete elimination of the consequences of that occupation (the schematic map of the occupied territories of the Republic of Azerbaijan is enclosed).

The seven districts surrounding Nagorno-Karabakh are as follows:

- Cachyn
- Kalbajar
- O Aghdam
 - Fuzuli
 - Jabrayil
 - Gubadly
 - O Zangilan

Regions or areas falling outside the (de facto) control of the country's government:

In 2008, Kosovo Albanians declared its independence unilaterally, which has never been recognised by the Republic of Serbia. Therefore, Kosovo and Metohija are politically disputed between the Government of the Republic of Serbia and the Provisional Institutions of Self-Government in Priština. SRB (Republic of Regions or areas falling outside the (de facto) control of the country's Serbia) government: Kosovo and Metohija, the southern Province of the Republic of Serbia, is currently outside the de facto control of the Serbian Government.
